Govt. employees Deposit-Cum-Insurance Schemes, 2018, prepared by a qualified actuary (Fellow of Institute of Actuaries of India) having a valid certificate of practice (CoP) in life Insurance satisfying the norms of appointed actuary (life) as prescribed by IRDAI (Appointed Actuary) Regulations, 2017.
